ORGANIZERS

The Balaghat Mine is the largest mine of the Company with a depth of about 435 meters. Dongri Buzurg opencast mine produces manganese dioxide ore used by dry battery industry. This manganese ore is supplied to steel, ferro & silico manganese plants. MOIL fulfils about 46% of the total requirement of dioxide ore in India. MOIL also has its own EMD and ferro manganese plants. At present the annual production is around 1.3 million tons. The company has initiated green mining initiatives like land reclamation using biotechnology, wind energy farm, solar power plants etc under the dynamic leadership of CMD Shri Ajit Kumar Saxena.

Mineral Exploration and Consultancy Limited (MECL) (Formerly Mineral Exploration Corporation Ltd.) was established for systematic exploration of minerals, to bridge the gap between the initial discovery of a prospect and its eventual exploitation. MECL has the Mission "to provide high quality, cost effective and time bound geo-scientific services for exploration and exploitation of minerals." MECL has completed over 1621 projects/reports and established 199527 Million Tons of ores/mineral reserves of
